

The following professor position (W3) is open at ESCP Europe Business School Berlin, starting **September 2019 or January 2020:**

Professor for Strategy (W3) (m/f/d)

ESCP Europe is looking for a candidate who covers the strategy field in teaching and research. We encourage applications with a research focus on strategy, with particular emphasis on new technologies and digital strategy. Previous research and publications should demonstrate the candidate's ability to combine rigour with relevance. The ideal candidate should enjoy teaching and be ready to teach in ESCP Europe's new Bachelor programme as well as in our graduate and executive education programmes. A strong candidate should demonstrate a good fit with the requirements of a modern Business School in the age of digitalization.

Requirements:

Candidates are expected to publish in top-quality academic journals. Teaching will take place in undergraduate, graduate and postgraduate programmes, as well as in executive education. It is possible to teach entirely in English but candidates are expected to have a basic knowledge in German or to show the willingness to learn German. We are explicitly looking for candidates applying new on- and offline teaching methods and (digital) formats. A willingness to work with colleagues from our network of ESCP Europe campuses in London, Madrid, Paris, Torino, & Warsaw is expected. Furthermore, candidates should demonstrate skills in developing and expanding relationships with companies and professional organisations, and extend the reputation of ESCP Europe Business School Berlin and its programmes.

ESCP Europe Berlin is a state-accredited, research-based business school (wissenschaftliche Hochschule). Therefore, §100 BerlHG (Berliner Hochschulgesetz) applies in the case of professors (habilitation or equivalent achievements). § 102a BerlHG applies in the case of assistant (junior) professors. Tenure can be offered for assistant professors after positive interim and final evaluations.

Applications should include: 1) a cover letter, 2) a curriculum vitae, including diplomas and transcripts of records (starting with A-levels), 3) a list of publications, 4) a statement of teaching and research interests and 5) teaching evaluations from the past two years.
